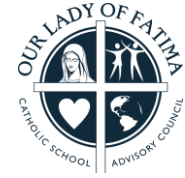

Principal and teachers will acknowledge student examples of actively living their faith as Joyful Disciples of Christ.</p> <p>Our School will assist in raising money and/or resources for those in need within our school, our local and global community (while respecting Covid-19 restrictions).</p>	<p>Staff, parents, and students will be knowledgeable about the District and School Code of Conduct and respect/follow the expectations set out. It will be communicated to all members of the school community (e.g., School Website, Electronic Newsletter).</p> <p>Students will have a deeper understanding of the Gospel message and how it can be connected to our lives today (e.g., through Liturgies, Religious Education and Family Life classes, and acts of service). Students who are having suicidal ideation and self-harm will be connected to help. Families will feel supported with regards to suicide prevention/support. Principal and other trained staff will state an increased comfort and ability to support students/school in times of crisis.
	2.Continue to focus on and educate about the legalization of recreational cannabis as well as vaping and smoking and long-term health effects.	Continue to educate and support staff in promoting safe and healthy school communities in relation to recreational cannabis, vaping and smoking during classroom lessons and teaching. Use of Health Unit resources/discussions as part of our school collaborative Wellness Plan. Student self directed D2L resource being created by Dr. Tara Bruno, in consultation with students from BHNCD SB and GEDSB.	Talks will be age appropriate and relevant with the classroom and students will better understand the impact of early cannabis, vaping and smoking use and their long-term effects. Continue professional learning and growth, including bullying recognition and response, will be accessible for all St. Mary Catholic Learning Centre staff. Human Trafficking Policy to be developed as per ministry direction by January 2022. Roll out of protocol and education to follow.	Staff will acknowledge more understanding and comfort regarding issues surrounding safe schools. Consistent approaches and practices will be in place.
	4. As a school, we will participate in Bullying Awareness & Prevention Week during the designated week in November 2021.	Daily prayers & reflections will take place as well as classrooms utilizing supports and activities during the week of Bullying Awareness in November. School Twitter feed will showcase the work we are engaging in during Bullying Awareness week as well as messages related to Bullying Awareness and Prevention. Note - Package typically shared with schools may not be released at the board level this year.	Staff and students will acknowledge more understanding of what it means to live as joyful Disciples in a peaceful, inclusive, respectful community as well as a community of kindness. This new gained knowledge will be visible in daily interactions of students and staff within our school. Continued compassion will be demonstrated by staff and students.
	5. Implement the practices that are within the revised Emergency Response Binder as required.	Revised Emergency Response Binder will be shared & reviewed with staff during 2021-2022 school year.	In the event of emergencies, the Emergency Binder material will be followed. Revised Emergency Response Binder informs school practices and procedures.
	6. School staff will be introduced to and supported through the stages of Self Regulation.	Staff will increase capacity of Self-Regulation using the work of Dr. Shanker during our Professional Development Day – October 8, 2021. Select staff and administrators will work through the modules of self-regulation to build school leads.	School staff will better understand and respond to supporting and assisting students in co-regulating with increased comfort.
